## Terms & Conditions

### Promoter

The promoter of this promotion is GreenBrook Electrical Ltd (“GreenBrook”, “we”, “our”, “us”).

### 1 Promotion Period

The “Box 2 Box” promotion runs from **00:01 on 1 June 2026 until 23:59 on 20 July 2026** (“Promotional Period”). Orders placed outside of this period will not qualify.

### 2 Eligibility

- 2.1 The promotion is open to UK electrical wholesalers and trade customers holding an active GreenBrook account.
- 2.2 Employees of GreenBrook, its subsidiaries, agents, distributors, or anyone professionally connected with the promotion are not eligible to participate.
- 2.3 GreenBrook reserves the right to verify the eligibility of any participant and may disqualify any participant where there are reasonable grounds to believe the promotion has been misused.

### 3 Qualifying Products

### 4 5% Credit Note Reward

- 4.1 Customers placing qualifying orders during the Promotional Period will be eligible to receive a 5% credit note based on the total net value of qualifying purchases.
- 4.2 Credit notes will be issued to the participating customer’s head office or buying group office during the week commencing 5 October 2026.
- 4.3 The 5% credit note is in addition to any existing online account discount arrangements, including the standard 1% online discount where applicable.
- 4.4 Only fully paid qualifying invoices will be included in the final credit note calculation.
- 4.5 Returned goods, cancelled orders, disputed invoices, or unpaid balances may be excluded from the calculation.
